- Preferred on PDL: Bupropion SR 150; Commit lozenge; Nicoderm; Nicorette; nicotine gum; nicotine patch; Chantix for 18 yrs. and older
- Non-Preferred on PDL: Nicorelief; Nicotrol NS; Nicotrol Inhaler

Reimbursement is available to pharmacy providers for over-thecounter and prescription smoking cessation products when prescribed by a licensed practitioner within the scope of his/ her license under Indiana law within the 24-week treatment timeframe.

Tobacco dependence pharmacotherapy is available for up to 180 days per member per calendar year. Treatment beyond 180 days within a calendar year will require the prescriber to document the medical necessity of continued treatment.
